- HP Partner Training Passes may only be used for HP Partner Training provided by HP Education Services in the US and Canada. Your Partner Pass can also be used for select HP industry events. Applicable courses may be found on the HP Partner Training Schedule. The current HP Partner Training Schedule can be accessed online through the [HP Partner Portal](#) (go to *Train & Certify* ▶ *Local Learning & Events* ▶ *Enterprise Storage and Servers (ESS) Training Schedule*).
- **EXCEPTION:** Training Pass funds cannot be used for non-HP industry events or training provided by other HP organizations. Funds from the HP Partner Training Pass cannot be used for training on HP Software products and services from www.hp.com/software/education.
- The HP Partner Training Pass can only be used for HP Education delivered training and cannot be used for Pearson VUE certification exams.
- The duration of the HP Partner Training Pass is 12 months from the date of activation. “Refills” can be purchased anytime during this period, however, those funds are subject to the same expiration date.
- Training must be scheduled prior to the Training Pass expiration date.
- Any unused funds at expiration are forfeited and no extension beyond expiration is permitted.
- HP Partner Training Passes purchased in the U.S. or Canada can be used for training deliveries and select HP industry events within these countries.
- The HP Partner Training Pass is sold in increments of \$100 with a minimum purchase of \$500. Refills are sold in increments of \$100 with a minimum purchase of \$100. Payment is due in full, upon placing *the initial order*.
